The goal of Northland Therapeutic Riding Center is to improve the quality of life of persons with special needs, and create a sense of hope in their future. Therapeutic Riding uses equine-oriented activities to positively impact the cognitive, physical, emotional, and social well-being of people with special needs from ages 2 to 80 years.

In 2014, Northland Therapeutic Riding Center completed and passed accreditation to become a "Premiere Accredited Center." Five, six week therapeutic riding sessions were conducted successfully. More than 82 riders with a wide variety of challenges were served, including riders with Down syndrome; speech, vision, and hearing challenges; cognitive challenges; and autism. Participants met an average of 88% of their goals in the areas of gross motor skills, fine motor skills, and behavioral/social skills receiving therapeutic riding. Staff spoke at the following organizations: UPS, Rotary, Optimist - Excelsior Springs, Mariner Corp. Informational booths were set up at Ability Quest and Liberty Fall Festival. NTRC participated in the Jesse James Day Parade. Cerner employees volunteered during "Impact Week." * 8 Cerner employees completed a 40 hour sabbatical volunteering * NTRC was the recipient of a grant from Variety of Kansas City, with 4 other grant requests completed and submitted. We held our second major fundraiser "Evening of Hope," as well as 2 other fundraisers - Casino Night and Triple Crown. NTRC conducted its annual horse show for the center's riders. NTRC continued to develop its relationships with community organizations that serve our riders, including hospitals, rehabilitation centers, and non-profits. NTRC worked to improve its trail area.

Veteran's Program - Boot Camp is an individually tailored program for veterans as well as service men and women who would like to experience the healing benefits of horses and nature as they transition between the military and civilian cultures. These, as well as post traumatic stress challenges, can be seen and conquered in creative ways when horses become part of the strategy. NTRC provides both un-mounted and mounted programs. Thank you service men and women. We look forward to talking with you about our services and our magnificent equine partners.

Mental Health Program - Our Hope and Horses mental health program offers an opportunity for those who face challenges from acute stress to chronic and persistent conditions.
